How to Register?

Registration with Public Purchase takes three (3) simple steps:

Step One: <u>Register with Public Purchase</u>. Use the link below to begin the registration process. It can take up to 24 hours for your account to become active. You will receive an email from <u>notices@publicpurchase.com</u> letting you know your account has been activated. Be sure to add this email address to your contact to avoid the bid notification emails being send to your junk folder. If you have already registered with Public Purchase previously, please proceed to step two (2).

Step Two: <u>Register with the Association of Educational Purchasing Agencies.</u>

- Once you have received your activation email from Public Purchase, log into <u>www.publicpurchase.com</u> and accept the terms and conditions of use.
- Click on the "Tools" tab, click on the "Agencies" tab.
- This will take you to the agency search page. In the agency name box, type in the name "Association of Educational Purchasing Agencies". Leave the "New Agency Since" box blank. Make sure registration status says "All". Click on "Search", this will bring up the agency below, to the far right of it you will see "View" and "Register with Agency" link to complete the vendor registration with the Association of Educational Purchasing Agencies.

Step Three: <u>Code Selection.</u> You will need to select the National Institute of Governmental Purchasing (NIGP) code(s) that relate to your business so you can receive email notifications of future bid opportunities that match the code(s) you select.

Please note, it is important that the second part of the registration is complete or you will not receive notifications of upcoming bid opportunities from AEPA. It is your responsibility to keep your organization's information up to date, particularly the contacts, NIGP codes, and email addresses. 
